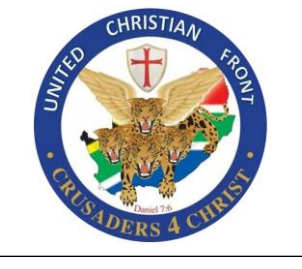
1. DECLARED MILITARY LOCKDOWN – HOUSE ARREST OF 70 MILLION PEOPLE – **LOST FREEDOM!**
